*Lorraine Coons* is assistant professor of history and college archivist at Chestnut Hill College in Philadelphia. She holds an undergraduate degree from Georgian Court College in New Jersey and a master's degree and doctorate from New York University, where she earned a certificate in archives management and historical editing. Current research focuses on French and women's history, particularly French women's peace activism in the 1930s.

Special interests include Australian library history and reference materials, and library planning and design.

*Peter J. Wosh* is director of the Archives Program at New York University. He had served previously as director of the archives and library at the American Bible Society. He holds an undergraduate degree in history from Rutgers University and a master's degree with a Certificate in Archival Management from New York University, where he also earned a Ph.D. in history.
