

## CONTRIBUTORS

*Jon Arvid Aho* is a doctoral student at the Graduate School of Library and Information Science, University of Texas at Austin, where he received the M.L.I.S. degree. He has degrees in theology (M.Div. and S.T.M.) from Concordia Theological Seminary, Fort Wayne, Indiana, and in history (M.A.) from Western Washington University, Bellingham. Prior to his library studies, he was in the Christian ministry from 1979, holding a variety of pastorates as well as working in theological libraries. His academic and professional interests include the history of books and libraries, the early Christian Church, and theological librarianship.

*Elizabeth R. Cardman* is the assistant university archivist at the University of Illinois at Urbana-Champaign. Her responsibilities include management of the ALA Archives, which are maintained by the University of Illinois Archives. She holds a Ph.D. in library and information science from the University of Illinois at Urbana-Champaign. Her research interests include nineteenth-century librarianship and the history of women professionals.

*James V Carmichael, Jr.*, is associate professor in the Department of Library and Information Studies at the University of North Carolina at Greensboro. He received his bachelor's degree in French and his M.Ln. from Emory University, and his Ph.D. from the University of North Carolina at Chapel Hill. He is the editor of *Daring to Find Our Names: The Search for Lesbian Library History* (1998) and has written extensively on Southern library history and gender issues.

*Richard J. Cox* is associate professor in archival studies at the University of Pittsburgh School of Information Sciences. He holds an undergraduate degree in history and English, the M.A. in history from the University of Maryland, and the Ph.D. in library science from the University of Pittsburgh. He has published more than one hundred articles and four books on all aspects of archives and records management, including *Documenting Localities: A Practical Model for American Archivists and Manuscript Curators* (1996). Elected a fellow of the Society of American Archivists in 1989, he edited *American Archivist* from 1991 to 1995.

*Phyllis Dain* is professor emerita of library service at Columbia University. She is the author and editor of numerous books and articles on library history, including, most notably, *The New York Public Library: A*

*History of Its Founding and Early Years* (1972) and, most recently, *Civic Space/Cyberspace: The American Public Library in the Information Age* (1999) with Redmond Kathleen Molz.

*Donald G. Davis, Jr.*, is professor of library and information science and of history at the University of Texas at Austin, where he has taught since 1971 and has edited *Libraries & Culture* since 1977. His academic preparation includes degrees in history from UCLA and the University of California, Berkeley, and professional degrees from Berkeley and the University of Illinois at Urbana-Champaign. Considering his vocation to be the promoting of historical perspectives within his profession, he has been a part of a number of national and international publishing and conference-planning projects. He has edited several reference works, including *American Library History: A Comprehensive Guide to the Literature* (1989) with John Mark Tucker and *Encyclopedia of Library History* (1994) with Wayne A. Wiegand, as well as numerous articles, book chapters, and review essays.

*Edward A. Goedecken* is humanities bibliographer at Iowa State University. He holds a bachelor's degree in American history from William Penn College, a master's in American history from Iowa State University, an MLS from the University of Iowa, and a Ph.D in American history from the University of Kansas. His research interests include citation studies of humanities literature as well as identification of current historical writings on libraries and book culture for the bibliographies that appear twice-yearly in the *LHRT Newsletter*. He also produces the biennial survey of the literature of American library history for *Libraries & Culture*.

*Suzanne Hildenbrand* is associate professor in the School of Information and Library Studies, SUNY/Buffalo. She received her B.A. from Brooklyn College, her M.S. from Columbia University, and her Ph.D. in education from the University of California, Berkeley. From 1962 to 1966 she served with the U.S. Information Agency. Her varied background includes work as a librarian for several California community colleges, librarian and teacher in the New York City schools, and positions with the U.S. Department of Defense schools overseas. Her special interests are equity issues, such as those reflected in women and librarianship, and information access in the age of information as a commodity. Her recent project is *Reclaiming the American Library Past: Writing the Women In* (1996).

*Christine A. Jenkins* is assistant professor at the Graduate School of Library and Information Science at the University of Illinois at Urbana-

Champaign, teaching courses in youth services, young adult literature, gender issues, and professional foundations and history. She received her M.L.S. from the University of Wisconsin–Madison and a master’s degree in children’s literature from Eastern Michigan University and served as a school media specialist in the Ann Arbor Public Schools before completing her doctorate at Wisconsin–Madison. Author of several articles and chapters in collected works, her interests center on young people’s texts and reading practices, the children’s canon, youth services librarianship, and intellectual freedom.

*D. W. Krummel* is professor emeritus of library and information science and of music at the University of Illinois at Urbana-Champaign, where he has taught since 1970. He earned undergraduate degrees, a master’s degree in music, the M.A.L.S., and the Ph.D.—all from the University of Michigan. He has been on the staff of the Library of Congress and has been a Guggenheim Fellow. A frequent contributor to scholarly publishing projects, he focuses his interests on the history of libraries and of bibliography, research collection development, and music bibliography. He is the author of a number of books as well as numerous articles and critical reviews.

*Mary Niles Maack* is professor in the Department of Library and Information Studies at the University of California, Los Angeles. With undergraduate degrees from the University of Illinois at Urbana-Champaign and master’s and doctoral degrees from Columbia University, she has been a national leader in studying the role of international relations in the profession, particularly in the Francophone world, and in the role of women in the library profession.

*Cheryl Knott Malone* is assistant professor in the Graduate School of Library and Information Science, University of Illinois at Urbana-Champaign. A graduate of the University of Houston, she holds an M.L.S. and an M.A. degree from the University of Arizona and the Ph.D. from the University of Texas at Austin. participant in the ALA Library History Round Table. His publications include books and essays on book and library history, including *An American Library History Reader* (1961) and *Louis Shores, Author-Librarian: A Bibliography* (1979).

*Lee Shiflett* is professor at the School of Library and Information Science at Louisiana State University in Baton Rouge, where he has been a member of the faculty since 1979. He is the author of *Origins of American Academic Librarianship* (1981) and *Louis Shores: Defining Educational Librarianship* (1996), and is currently working on a study of the editorial career of William Terry Couch. He served as chair of the Library History Round Table in 1984.

*John Mark Tucker* is humanities, social science, and education librarian and professor of library science at Purdue University. A graduate of David Lipscomb University, he received the M.L.S. and Ed.S. degrees from George Peabody College for Teachers of Vanderbilt University and the Ph.D. from the University of Illinois at Urbana-Champaign. His research interests include the history and biography of academic librarianship, especially the period of the late nineteenth and early twentieth centuries. His publications include *American Library History: A Comprehensive Guide to the Literature* (1989) with Donald G. Davis, Jr., and *Untold Stories: Civil Rights, Libraries, and Black Librarianship* (1998).

*Andrew B. Wertheimer* is a doctoral candidate in the School of Library and Information Studies at the University of Wisconsin–Madison and is research assistant professor at the University of Nebraska–Lincoln. Since completing his M.L.S. from Indiana University, he has assisted in numerous projects relating to library history in the national profession. His research centers on ethnic print cultures, historiography, and library history.

*Wayne A. Wiegand* is professor in the School of Library and Information Studies at the University of Wisconsin–Madison, where he also serves as codirector of the Center for the History of Print Culture in Modern America. He is the author of over sixty scholarly articles and several monographs, the latest of which is *Irrepressible Reformer: A Biography of Melvil Dewey* (1996), which won the 1998 G. K. Hall Award for Outstanding Contribution to Library Literature. *Print Culture in a Diverse America* (1998), an anthology he co-edited with Jim Danky, won the 1999 Carey McWilliams Award for its contribution to multicultural literature.
